

**ASSOCIATED BUILDERS AND CONTRACTORS EVENT  
PERSONAL ACCOUNTABILITY AND RESPONSIBILITY COMMITMENT DOCUMENT**

Associated Builders and Contractors is offering in-person attendance at its ABC Legislative Day in Jacksonville, Florida to members, guests and staff pursuant to local government orders permitting such gatherings at this time. ABC requires all members, guests, staff and vendors' personnel to comply with safety precautions specified at the Sawgrass Marriott Resort in addition to state, local government and CDC guidelines. Any person disclosing or exhibiting symptoms of COVID-19, or knowingly exposed to the disease, will be refused admittance to the ABC event. Any person refusing to comply with required safety protocols will also be asked to leave the event.

**I confirm that I have not knowingly been exposed to anyone testing positive for or presenting symptoms of COVID-19 within the last 14 days, or else as a result of an exposure I have quarantined for a minimum of 10 days without testing, or after Day 7 after received a negative test result (the test must occur on Day 5 or later) and have not myself tested positive or presented any such symptoms, including: temperature over 100.4 F, loss of taste or smell, dry cough, runny nose or sore throat. \_\_\_\_\_ (Initial)**

**I confirm that while attending ABC's Legislative Day, I will wear a face covering/mask unless I have been fully vaccinated, and I will maintain appropriate social distance. \_\_\_\_\_ (Initial).**

Unfortunately, the virus continues to spread from person-to-person contact and other means, and people reportedly can spread the disease without showing symptoms. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

**Therefore, if you choose to participate in this ABC event, you may be exposing yourself to or increasing your risk of contracting or spreading COVID-19, despite our safety precautions.**

**ASSUMPTION OF RISK: I have read and understand the above warning concerning COVID-19.** In exchange for being allowed to participate in ABC's event, I hereby choose to accept the risk of contracting COVID-19 for myself or my family.

**WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against ABC and its officers, directors, managers, officials, trustees, agents, employees or other representatives in connection with exposure, infection and/or spread of COVID-19 related to my participation in ABC's Legislative Day.** I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss based upon claims of negligence.

**CHOICE OF LAW:** I understand and agree that the law of the District of Columbia will apply to this contract.
